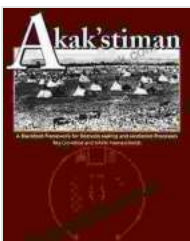

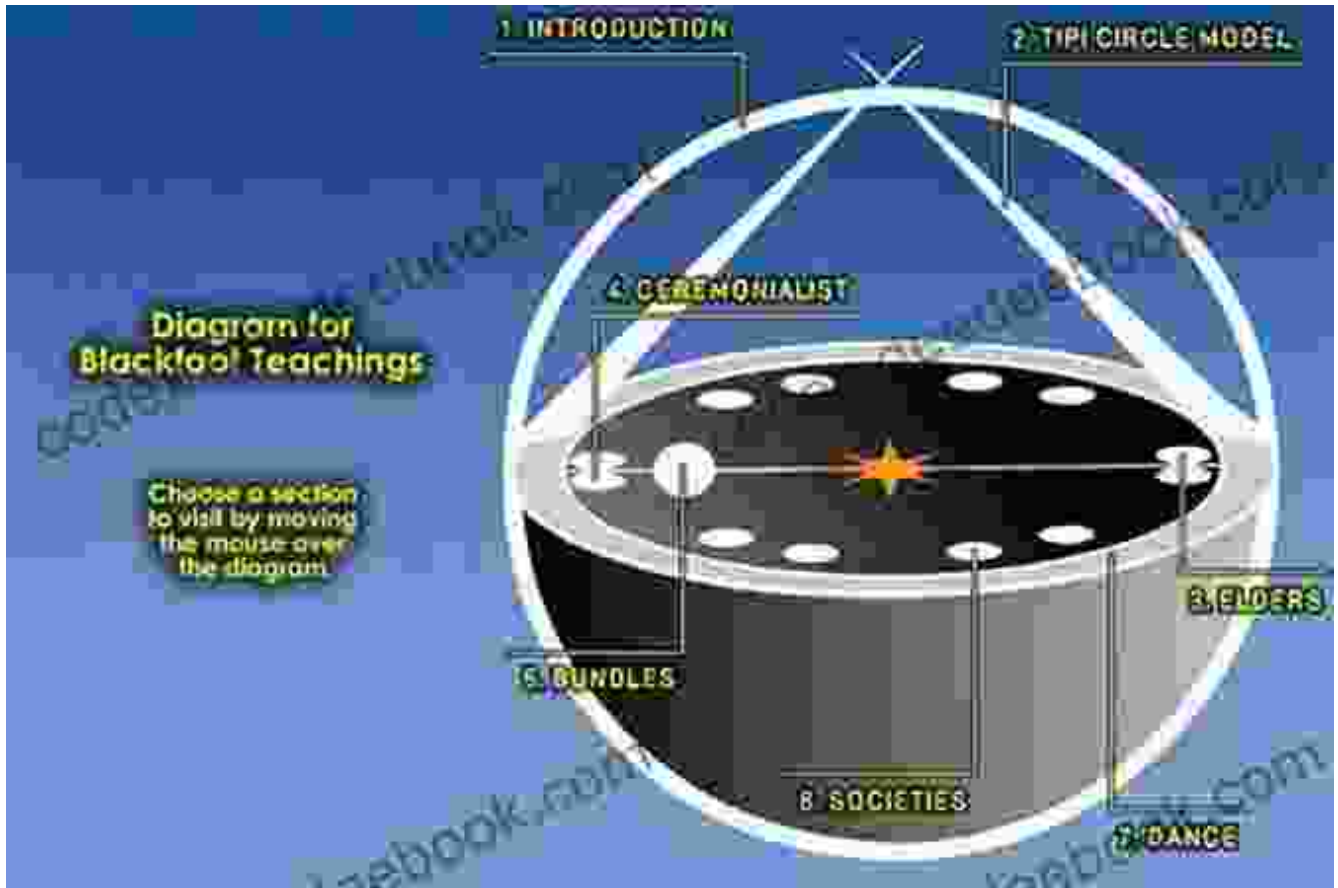

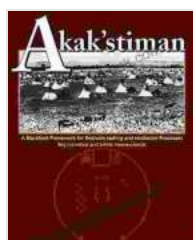
This image depicts the collaborative and inclusive nature of the Blackfoot Framework.

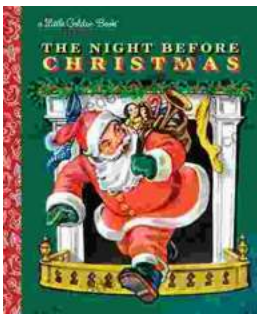

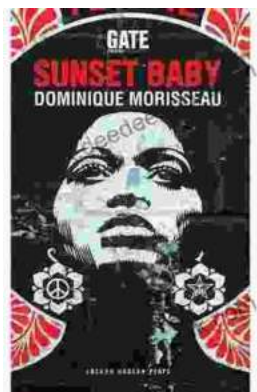
